

# Walking and Cycling Improvements on Queen Edith's Way

## Your feedback matters

Last year we sought your views on improving Queen Edith's Way. The feedback told us:


**67%** of you felt that improvements were needed to the cycling and walking facilities.

**32%** of you felt unsafe cycling, with a further **7%** feeling very unsafe.

**24%** of you feel safe cycling along Queen Edith's Way with a further **5%** feeling very safe.

**48%** found the Queen Edith's Way/Fendon Road Roundabout to be a key safety issue for cyclists.

We held a workshop in March 2016 with local groups, stakeholders and businesses. The aim of this workshop was to come up with a range of options to tackle the walking and cycling issues on Queen Edith's Way. The options we are putting forward are a result of the feedback from the 2015 consultation and the 2016 workshop.



# Why are improvements needed?

Queen Edith's Way is an important route to local schools, Peterhouse Technology Park (PTP), Addenbrooke's Hospital and the Biomedical Campus. The growth of PTP and Addenbrooke's will mean an increase in road users along this route. The existing infrastructure is poor and needs to be improved.

During the past five years there have been 33 accidents along Queen Edith's Way, 25 of which have involved a car and a cyclist. The majority of these accidents have been at side road junctions and the Fendon Road roundabout. The road needs to be improved for the safety of all road users.

# **Costs and Funding**

Local developers are contributing £3 million to cycling and junction improvement schemes on Queen Edith's Way, Cherry Hinton Road and the Robin Hood junction.

The improvements to the Robin Hood junction will be carried out by the Traffic Signals team. New proposals for Cherry Hinton Road are at a very early stage of development.

Option 2 would be considerably more expensive than Option 1; if it turns out to be the preferred Option, we may only be able to construct part of it until further funding is found.

#### Section 1

#### Hills Road to Fendon Road Roundabout

This section of Queen Edith's Way is part of the inner ring road. It attracts a larger volume of traffic than the section of road east of Fendon Road roundabout (Section 3). The combined width of the carriageway, footpaths and verges, at an average of 17 metres, allows us to propose 2 options both using a raised hybrid cycle lane and the new 'Cambridge' kerb. This is currently being installed along Hills Road.


#### OPTION 1

This option retains part of the grass verge between the property boundary and the footpath.



#### OPTION 2


Under this option a new grass verge would be created between the footpath and the cycle lane where new trees and lamp columns could be located. The existing grass verge between the property boundary and the footpath would be removed.



Option 2 would be considerably more expensive than Option 1. It would also require the cutting back and removal of any vegetation that is found to be overhanging or within the highway boundary. We appreciate this is a sensitive matter and is something that would be carried out on a property by property basis.

# Roadside verges

To improve the footpaths and cycleways along Queen Edith's Way we would need to remove the current roadside trees and verges. For those options that include an avenue of trees in a grass border between the footpath and cycleway, we would need to cut back all vegetation to the edge of the highway boundary.

# **Bus stop locations**

To improve Queen Edith's Way for pedestrians and cyclists, we will have to relocate some of the existing bus stops along Queen Edith's Way. ## **Section 3**

# **Fendon Road Roundabout to Cherry Hinton Road**

This section of Queen Edith's Way is not part of the inner ring road and will soon have a 20mph speed limit. The general width (average 15 metres) is not as great as Section 1 and therefore the 2 options would involve narrowing the carriageway to better reflect the new speed limit, and the provision of on-road advisory cycle lanes. As part of the scheme there would be new double yellow lines from Wulfstan Way to Cherry Hinton Road (there would be no loading restrictions).

#### OPTION 1

This option retains part of the grass verge between the property boundary and the footpath.



#### OPTION 2

Under this option a new grass verge would be created between the footpath and the cycle lane where new trees and lamp columns could be located. The existing grass verge between the property boundary and the footpath would be removed.
